IV. Lutherans believe that the Bible alone is the final authority for Christian teaching. Part 3

Because we Lutherans believe that the Bible alone is the final authority for Christian teaching, it is also characteristic of us to reject all teachings and writings that are contrary to the Holy Scriptures, even if those teachings and writings come from the supposed authority of visible church hierarchy, or from what claims to be religious scholarship.

Here we need only let the Scriptures speak for themselves. They contain many warnings against false prophets – people who claim to speak for God, but who speak falsehood instead. Jesus said, "Take heed that no one deceives you, for many will come in My name, saying, 'I am the Christ,' and will deceive many. ...Then many false prophets will rise up and deceive many. ...Then, if anyone says to you, 'Look, here is the Christ!' or 'There!' do not believe it. For false christs and false prophets will arise and show great signs and wonders, so as to deceive, if possible, even the elect." *Matthew 24:4-5,11,23-25*

God also says through the apostle Peter, "Bear in mind that our Lord's patience means salvation, just as our dear brother Paul also wrote you with the wisdom that God gave him. He writes the same way in all his letters, speaking in them of these matters. His letters contain some things that are hard to understand, which ignorant and unstable people distort, as they do the other Scriptures, to their own destruction. Therefore, dear friends, since you already know this, be on your guard so that you may not be carried away by the error of lawless men and fall from your secure position." 2 Peter 3:15 -17

God warns us in these passages against falsehood that comes from within the visible church – from men who claim to be religious authorities. They make false claims and twist the Scriptures. We Lutherans refuse to follow them simply because they claim some sort of church authority. If they speak contrary to the Word of God, we reject them. You may also read Galatians 1:6-9, 2 Corinthians 10:4-5, and 1 Timothy 6:3-4 for more warnings against falsehood that comes from people who claim religious authority.

At the same time, the Bible warns us against falsehood that comes from fallen human reason or philosophy. In the name of "Biblical" scholarship, science, enlightened reason, or progressive thought, people speak and write all sorts of things that are not compatible with the truth of God's Word. So God tells us to watch out. He said through Paul, "Beware lest anyone cheat you through philosophy and empty deceit, according to the tradition of men, according to the basic principles of the world, and not according to Christ." *Colossians* 2:8 Again "For it is written: 'I will destroy the wisdom of the wise, and bring to nothing the understanding of the prudent.' Where is the wise man? Where is the scribe? Where is the debater of this age? Has not God made foolish the wisdom of this world?" *I Corinthians* 1:19-20

Therefore when we Lutherans hear claims from people who fancy themselves scholars, scientists, philosophers, academic elitists, or other self-proclaimed intellectuals, but their ideas go against the Word of God, we reject them. We trust the Lord and His Word, confident that He will destroy the so-called wisdom of the "wise."

Here is an example of what we Lutherans confess regarding religious authorities who are in error: "They (our Roman opponents) quote the statement, 'Obey your leaders.' This statement requires obedience to the Gospel; it does not create an authority for bishops apart from the Gospel. Bishops must not create traditions contrary to the Gospel. When they do so, we are forbidden to obey them by the statement, 'If anyone preaches another gospel, let him be accursed.' *Galatians 1:8*" - Apology (Defense) of the Augsburg Confessions XXVIII:20 For more related passages from the Lutheran Confessions, read Augsburg Confession XXVIII:21-25, Smalcald Articles II.IV:14, and Treatise 55-57.


Concerning falsehood promoted by what claims to be human reason, we Lutherans hold to this: "We dare not permit any objection or human contradiction, spun out of human reason, to turn us away from these words (the words of Jesus), no matter how appealing our reason may find it." - Formula of Concord, Solid Declaration VII:45

HI-LITES OF ST. JOHN'S VOTERS ASSEMBLY September 9, 2024

Ross Gould called the meeting to order. A quorum was present. Pastor Bishop opened with devotions.

The June, July, and August Parish Reports were reviewed. A motion was made by Nancy Drockelman, seconded by Diane Gould, to approve the June, July, and August Parish Reports. Motion carried.

The June meeting minutes were reviewed. A motion was made by Julie Wagner, seconded by Cheryl Ivey, to approve the June meeting minutes. Motion carried.

Treasurer's Report - Rod Bollinger presented the June, July, and August Treasurer's Reports. Rod highlighted those payments that are not typical monthly expenses. July's income included the quarterly payment from Xfinity for rental of the property on Veterans Drive. July's expenses included the quarterly payment for insurance and for some roofing repairs. A question was asked about the increase in the payment to Good Shepherd Lutheran School. Enrollment increased so our monthly payment increased. The cost per student to the GSLS member congregations is a little over \$13,000. The formula for our portion of the payment is based on the average enrollment over a 3-year After August, our year-to-date deficit is sitting at around \$16,300.00. A motion was made by Dave Kesselmayer, seconded by Nancy Drockelman, to accept the June, July, and August Treasurer's Reports. Motion carried.

Board of Trustees – Dave Kesselmayer reported that the bell tower work will be completed this fall. Stratus is done with the work to update the phone system and the Wi-fi. The guest password is Stjohn711. Dave indicated that Sandy Ferguson will make placards showing the Wi-fi password to be placed around the church. The roof leak was fixed by Kreiling Roofing. There was also a roof leak at Ewe's Home Furnishings that was repaired by the Trustees. There was a plumbing leak for which repairs have been completed. The rack for the chairs has been installed. Dave met with the city about work on new sidewalks in conjunction with the upgrades being made to Court Street. A baby changing station has been installed in the women's restroom in the new addition. There will be a work day on October 12th. Rod Bollinger asked about a monthly payment being made to Yellow Pages for an ad. Tracy Glass reported that the Evangelism committee has decided to discontinue this expense. Tracy will check to see when the payments will end. Gary Pool led a discussion regarding the church cemetery. Gary indicated that the Trustees are considering the feasibility of opening the cemetery, located in the church's East Bluff property off Veteran's Drive, to our members and their families for future burial sites. This would involve selling plots in either the existing cemetery or adjacent land to the east of the cemetery.

The funds received from the sale of these plots would be placed in a single purpose trust fund to be used solely for the care and maintenance of the cemetery. A few members of the church have shown interest in burial plots if the Trustees were to move forward with these plans and some have expressed valid concern regarding the church's ability to care for the cemetery in the long term. If you are interested in the possible purchase of burial plots, please contact Gary Pool or one of the Trustees. Any thoughts regarding this are welcome at the next Voters Assembly Meeting. Further questions and discussion took place. Gary is going to do some more research surrounding possible costs, who could buy plots, etc.

<u>Board of Elders</u> – Ross Gould reported that the Elders had a couple of requests for assistance with Ameren bills for approximately \$200.00 each that were approved by the Elders.

<u>Board of Finance</u> – Nancy Drockelman reported that the committee plans to meet in September to get budget information ready to send out to the committees.

Board of Christian Education - Leslie Hauk reported that the youth's activity in July was mini-golf and the next activity on October 20th will be a wiener roast. thanked everyone who helped with Rally Day. Seven students were in attendance. An additional Sunday School teacher is still needed once a month for $Pre-K-2^{nd}$ grade. The committee is also looking for a replacement Sunday School teacher beginning January of 2025. Leslie thanked everyone who attended and helped with the Church Picnic. Good Shepherd Lutheran School will have their Jog-A-Thon this month. The board also discussed the rising costs of educating students at GSLS and the financial responsibility of church member parents. The approximate cost of education per student is \$13,000. Tuition is currently \$5,100 per year. The question brought forth, "how much should a member family be expected to contribute in offerings toward their student?" After discussion, the Board recommended that St. John's families with students at GSLS should be encouraged to contribute 40% of tuition or more if possible (\$2400). This would be in keeping with the spirit of the original design plan when the school was chartered. It was noted that another avenue to assist with tuition is by participating in the Script program.

John Neumann reported on the Good Shepherd Board meeting. John indicated that the board will be discussing whether to do away with the Script program as it is underutilized and takes a lot of time. Good Shepherd started the year with 121 students in Pre-K – 8th grade (in comparison, St. Josephs started with 47 students). John explained the increase in the monthly payment made by St. John's to GSLS. The capital campaign will kick off in October. Starting September 27th John will be talking to each congregation about the campaign. The goal is to pay off the mortgage by the 2026-2027 school year. John indicated that the school is fully staffed. It was noted that the proceeds from Ewe's Treasures and Ewe's Home Furnishings

have really helped the school. The board meetings have been changed from the 3rd Tuesday of the month to the 2nd Tuesday. Letters asking for donations to the capital campaign will go out in October.

<u>Board of Worship</u> – Julie Wagner reported that the committee met last week. There was no information to report at the current time.

<u>Board of Evangelism</u> – Tracy Glass thanked those volunteers who helped with the booth at the Marigold Festival. Tracy indicated that the board is considering doing a printed directory in the future. The board is also still looking for members.

Board of Stewardship - No report.

<u>Long Range Planning Committee</u> – No report.

<u>Educational Grant Fund Committee</u> – No report. A question was asked as to whether some of the money in this fund could be used to offset the increase in the monthly payment to Good Shepherd. Ross Gould indicated that recent changes to the funds mission statement could allow for interest earned on the money to be used for this purpose.

East Bluff Property Committee - No report.

<u>Constitution By-laws Committee</u> – No report.

<u>Unfinished business</u> – No unfinished business. A big thank you was extended to the Trustees for all the work they have been doing to make improvements at the church. It is greatly appreciated. Ross Gould also indicated that the number of members on boards have been down. Board chairpersons should be thinking about nominations for next year.

<u>New business</u> – No new business.

A motion was made by Bob Oliverius, seconded by Jennifer Kesselmayer, to close the meeting. Motion carried

The meeting closed with the Lord's Prayer.

Reversing Roe: Part 3 (provided by Peoria Area Lutherans for Life)

The 22-year effort by Allen E. Parker Jr., his team at The Justice Foundation, and several other pro-life organizations is too complicated to explain fully in this brief review, but if you read the whole story you will see that the words of God spoken to His people by the prophet Isaiah in chapter 28:14-22 were understood by Allen Parker to be a prophesy that the "covenant with death will be annulled", and the "pact with the grave will not stand" was also speaking about abortion in our time. Other verses spoke to him that God was telling him to undertake this seemingly impossible task. Many tools were used by The Justice Foundation to accomplish the miracle of reversing Roe after almost 50 years as the law of the land including:

- The Moral Outcry Petition declaring abortion to be a crime against humanity was signed by 539,108 Americans
- The sworn testimonies of 4728 women were filed by Operation Outcry describing how they personally were injured by abortion.
- Before The Moral Outcry Petition was born, a book called <u>The Law of Judicial Precedent</u> was co-authored by eight judges, including two appellate court judges named Kavanaugh and Gorsuch, saying that "severe criticism" was a valid reason to overturn a prior wrong decision.
- The first known legal brief ever to be filed with the U.S. Supreme Court by a formerly frozen embryo, Hannah S, who is now a college graduate.

"So this is an interesting story", you might say, "but now that the Dobbs decision has reversed Roe v Wade and legal abortion is no longer the law of the land, doesn't that pretty much settle it"? Watch for Part 4 next month.
